MINUTES OF THE ANNUAL GENERAL MEETING HELD AT THE WIMBLEDON CLUB ON THURSDAY 1 DECEMBER 2022

Present: Derek Howorth (President), Peter Bradshaw (Chairman), Roy Staniland (Secretary), Lynne Hunt (Treasurer) and 8 other members of the Council, Chris Risebro, Tim Sagar, Justin Sherring, Debbie Slater, Mandy Spicer, Julie Duckworth and Lewis Woodham (Surrey Tennis) and Joe Salisbury for the start of the meeting.

1. The President

The President, Derek Howorth, welcomed everybody. He thanked Joe Salisbury for coming to the meeting and there was a Q & A with Joe, led by Justin Sherring with various questions from the audience. There was a warm round of applause for Joe Salisbury, recognising his great achievements.

2. Approval of the Minutes of the previous AGM.

The minutes were taken as read and approved unanimously.

3. Election of Councillors and Reporting Accountant (Kreston Reeves LLP)

Peter Bradshaw explained that 4 Councillors were up for re-election, Alison Taylor, Sally Parker, Doug Clare and Kate Maurici. As there were no other candidates they were re-elected for 3 years without a vote. There was also one new nomination, Tunde Adefowora. As there were sufficient vacancies on the Council there was no need for a vote and he were elected and welcomed to the Council

The election of the Reporting Account - Kreston Reeves LLP It was passed unanimously.

4. Treasurer's Report – Adoption of Association Accounts for the year ending 30 September 2022

Lynne introduced the accounts and said that there had been a loss of £16,000. Income has been c. £350,000, including £150.000 sponsorship and £108,00 from the LTA. Renting the Office space in Esher has added to the expenditure. The County has a strong balance sheet

with good working capital. It is planned for a similar deficit in next year's budget, depending upon sponsorship, expenses etc.

Lynne explained that the Surrey is in the process of Incorporating and will become a Charity and a Trading Company. She also explained that there will be a new funding agreement with the LTA from next year. Surrey's income funding from the LTA is currently higher than the new proposed maximum but the LTA have agreed to maintain the current level of funding for 3 years. This applies to 2 Counties, Surrey and Middlesex. All other counties will be better off, with a substantial increase in funding for some. There was a discussion about the new contract and in particular the confidentiality clause which meant details of the contract cannot be discussed outside of Council meetings. Lynne made it clear that if we don't sign the contract we will not receive the funding. The point was raised that it was difficult to vote on something without knowing the details and the suggestion was that the AGM vote to return the decision for the Council to make. This was tabled as an amendment to the original proposal and was agreed by the meeting, with 1 vote against.

The Accounts were approved unanimously.

5. Accounts of the Surrey Junior Trust Fund for the year ending 30 September 2022.

Derek Howorth explained that The Surrey Junior Trust Fund is a small charity funded by donations from the County and a Charitable Settlement from Vernon Ely. This year the income has increased by £5,000 and £30,000 from the Vernon Ely settlement. Designated funds are retained for investment and the income from the investments is used to give grants to Surrey players. Grants of just under £32,000 have been made this year to 70+ junior players. It is based on ability and the best players get the biggest grants.

6. Report of the Council

Peter Bradshaw said that the excellent report showed what a great job is done by the team and he thanked Debbie Slater, Tim Sagar and Lewis Woodham, Judy Duckworth, Justin Sherring, Mandy Spicer and Chris Risebro for the work they do. Peter thanked the Councillors for all the work they do and mentioned the introduction of a new Coaches Committee. He also highlighted the fact that the Patrons Association was being closed down after 60 years.

Our goal for next year is Incorporation.

Alison ran through the presentation on the LTA strategy and highlighted the fact that Surrey will be setting up the first Padel League in January.
